Superintendent's High School report by Neil Hufnagel. Took a moment to thank his staff for helping out in communications, bond work, and graduation planning during his mother's illness.

- B. <u>Graduation Update</u>. Neil reported that graduation commencement will be held on Spicer football field limiting the number of people allowed inside the grounds in order to comply with the Governor's order. Graduation rehearsal is set for Thursday evening with commencement on Sunday.
- C. <u>Bond Update</u>. Neil reported that there will be a Special Edition Eagle Flyer next week that will feature only Bond related materials. There is an advocacy group in the community spreading the word to vote August 4.

This is a countywide survey discussed and implemented by Clinton County Superintendents. Stage 4 allows return to school. Stages 1, 2, and 3 does not.
